



TERMS AND CONDITIONS FOR STUDENT CURRENT ACCOUNT – COMPETITION 2026

- 1 – The promoter of this giveaway promotion is **Core Credit Union** (the “Promoter”).
- 2 – This Competition is sponsored, endorsed and administered solely by Core Credit Union. You are providing your information to Core Credit Union and not to any other third party. You must show evidence of study (including but not limited to your student number, student identity card, name of secondary school or third level institution, course of study and expected end date).
